Genealogical Research Locality Guide for Lafayette County, Mississippi

Historical Background

Located in northern Mississippi, Lafayette County was formed on 9 February 1836 from Monroe County from the Chickasaw lands and named for the Marquis de Lafayette, an American Revolution friend. Surrounding counties include: Calhoun, Marshall, Panola, Pontotoc, Tate, Union, and Yalobusha.

Lafayette County was largely an agricultural and livestock center at its foundation, and it was located on the Illinois Railroad making it a good locale of business. Early settlers were able to utilize its rolling hills and valleys to farm exceedingly well, making Lafayette County a prosperous location.


By a margin of only one vote over the coastal region, Lafayette County was chosen as the home of the University of Mississippi, which opened in 1848. The University survived the Civil War and is today a major university and learning center in the South.

The Civil War left Lafayette County in ruins. High taxes were levied to rebuild the roads, bridges, and courthouse, all of which were burned and destroyed during the war, and many people forfeited their land due to high taxation. Once begun, though, recovery was steady and swift, and by 1872 the county was well on its way to recovery.

Religious influences have traditionally been Baptist, Methodist, and Presbyterian. Churches suffered immeasurably as a result of the war, most falling to ruin by the end. Along with the economic recovery, churches were re-established throughout the county.

Of some interest to genealogists, the State Library Commission granted Lafayette, DeSoto, Tate, and Panola counties funds to create the first regional library system in 1950. The libraries cooperatively supply their holdings to the public, and by this, all holdings in the system are available to all patrons of any one of the member libraries.

Birth records:

Records prior to 1912 are not found in Lafayette County. In 1912, Mississippi began keeping birth records. The Mississippi Department of Health, Vital Statistics Office https://msdh.ms.gov/msdhsite/static/31,0,109,808.html has birth records from November 1912 forward available for order.

- "A certified copy of a birth certificate [less than 100 years since the birth] can be issued only to a person with legitimate and tangible interest as defined by the Rules Governing the Registration and Certification of Vital Events. Primarily this is:
- 1) Registrant (the child named on the record), if of legal age.
- 2) Parent(s) listed on the birth record, if VR office has not been notified of termination of parental rights.
- 3) Spouse, sibling(s), or grandparent(s)/child(ren) of registrant

- 4) Legal Guardian, guardianship papers must be provided.
- 5) Legal representative of one of the above persons, proof of representation must be provided.
- 6) Licensed adoption agencies working within the statutory authority of §93-17-205.
- 7) Other person(s) by court order, certified copy of court order must be provided.

[for certificates more than 100 years since the birth] For Genealogy purposes - Genealogy must be stated as purpose for certificate. Relationship to applicant must be provided. Plain paper copies are provided for genealogy purposes."

Marriage records:

Marriage records are kept by the State 1 January 1926 to 31 July 1938 and from 1 January 1942 to the present. The marriage records held in Lafayette County are stored in two different physical locations. All marriage records after 1944 are at the Lafayette County Circuit Clerk's Office and are available to the public. The Clerk's Office has marriage books prior to 1944 at the office, also available to the public. All known marriage documents (not marriage books) from 1861 to 1944 are housed by the Lafayette County Historical and Genealogical Society in their private collection in the Genealogical Room located in the Lafayette County Library. The Clerk's office discovered ten files of marriage records in a closet on the third floor of the courthouse in 2002. After speaking with the State Archives, the Circuit Clerk transferred the loose records to the then Skipwith Historical and Genealogical Society (now the Lafayette County Genealogical and Historical Society). In return for receiving the collection, the Society agreed to preserve, secure, and make the more than 19,000 loose records available to the public. Since receiving the records, the Society has indexed into two volumes the records by grooms' names and cross referenced them by brides' names. The indices use letter codes to indicate the type of document housed in the collection. They also placed each record/document into protective sleeves in binders. The binders are kept in a glass case that is locked at all times. Records for white marriages begin in 1861, and African American marriage records are found beginning in 1865.

Divorce Records:

The legislature decided divorce cases prior to 1840, and the State Department of Archives and History has an index to acts from 1817 to 1865 in which divorces are listed. The Lafayette County Chancery Court has divorces occurring after 1865.

Death records:

The Mortality Schedules of 1850, 1860, 1870, and 1880 are available on *FamilySearch* at https://www.familysearch.org/search/catalog/422723.

Death records prior to 1912 are not found in Lafayette County and were not required by the State. The Mississippi Department of Archives and History has death certificates from November 1912 to 1943 on microfiche. Indexes for these certificates are available at these three links:

- "A certified copy of a death certificate [less than 50 years since the death] can be issued only to a person with legitimate and tangible interest as defined by the Rules Governing the Registration and Certification of Vital Events. Primarily this is:
- 1)Parent(s) listed on the death record.
- 2)Spouse, sibling(s), or grandparent(s)/child(ren) of registrant, proof of relationship required.
- 3)Informant must be listed on death record.
- 4)Legal Guardian, guardianship papers must be provided.
- 5)Legal representative of one of the above persons, proof of representation must be provided.
- 6)Other person(s) by court order, certified copy of court order must be provided.
- 7) Funeral Home, must be the funeral home on record that took possession of the body.

[for certificates more than 50 years since the death] For Genealogy purposes - Genealogy must be stated as purpose for certificate. Relationship to applicant must be provided. Plain paper copies are provided for genealogy purposes."

Land Records/Wills/Estates/Guardianships/Adoptions/Tax Records/Military Discharges/etc.:

The Chancery Court holds these records for Lafayette County. Record keeping in the late 1800s to early 1900s for various types of records is intermittent. Some Chancery records are on microfilm with the Lafayette County Historical and Genealogical Society.

Newspapers:

The Mississippi Department of Archives and History has a searchable database of newspapers throughout the history of the State. *The Oxford Eagle* is the longest running paper for the area, and intermittent microfilm/digitized issues may be found at the University Library, the Oxford/Lafayette County Library, and some are held by the Lafayette County Historical and Genealogical Society in their private collection in the Genealogical Room in the Lafayette County Library. Short running papers include the *Globe, Ricochet, Shot, Intelligencer*, and *Falcon*. Intermittent copies of these may be found at the local libraries as well. The Chancery Clerk's Office has a store of hard copies of various newspapers for viewing.

The Library of Congress's website *Chronicling America* (https://chroniclingamerica.loc.gov/) lists the following as Lafayette County newspapers. To find copies, click on the provided link to go to that paper's listing. At the

Notes: The genealogy room (named the Kerin Coffey Magdovitz Genealogy

and History Research Room) is a privately owned, non-circulating collection tucked away in a corner on the second floor of the Oxford

library. It is owned by the Lafayette County Historical and Genealogical Society, established in 1967. The library allows the collection to be housed in the building, but no members of the library staff are responsible for its operation. Among its holdings are obituaries, cemetery records, Civil War records, Mississippi maps, how-to books, family histories, migration records, military records, marriage records, periodicals, census records, state and

county histories for multiple states, and numerous other materials.

Volunteers of the Lafayette County Historical and Genealogical Society are available to assist, but no regular hours or days are established for the volunteers to be present. The volunteers receive queries from the public for look ups and will make copies and/or source notes of findings for the requester. Referrals are made to other societies, libraries, agencies, and sources. No electronic catalogues exist for the genealogy holdings, and the card catalogue has not been maintained to include all holdings. Books are shelved in sections: family, county, periodicals, censuses, etc., but within

Carolina. Many genealogical periodicals are available. One of the three shelved walls is devoted to the periodical collection. The periodicals are in the process of being indexed and organized by two volunteers. Unfortunately, the genealogy room has very limited

newspapers on microfilm and none in the original. Microfilm for the Oxford Eagle is held for the dates 11Jan, 1883 - 12 Dec, 1883; 26 Nov 1936 - 5 May, 1939; and 25 Aug, 2004 - 22 Dec, 2004. Due to

the limited collection, referrals are frequently made to the nearby University of Mississippi's J. D. Williams Library, which has a vast collection of newspapers. The microfiche collection includes seemingly random censuses, indexes, and documentation.

city and county during the Civil War. It is worthy to note that the Circuit Court stores miscellaneous, old (uncatalogued) records in an old building in Taylor; therefore, no one can know for certain what

records are/are not extant for the county.

On 15 March 2021, the Lafayette County Board of Supervisors approved efforts to preserve the county's oldest **civil and criminal records** (1840s-1930s) by donating the files to the University of Mississippi. The University's Law School will organize and index the files over the next two years, and the files will not be available to the public during this time. Once the project is
