Please do not forget that grim note above!

Pleasant things are happening too. One of the most pleasant is the trip to Europe which our Director of Research, Miss Jessie T. Webb, is taking. Many of our good members have sent cards for our Master Surname File and requests for information. These are being held for answer until Miss Webb returns.

We were pleased with the response from our publishing of Mr. Prentice Price's talk in the first quarter's issue of 1967. One letter sent material which will also be of value to many of our members. Mrs. Sara Hurt Miller, 374 A Bergin Drive, Monterey, California 93940, was the contributor:

" ... a source of Land Grants which involved several Tennessee counties.

THE KENTUCKY LAND GRANTS, 1782-1924. Willard R. Jillson. 1925, Standard Printing Co., Louisville, Kentucky

(Index to Land Grants in State Land Office, Frankfort, Kentucky)

Included are:

- 1. Virginia Land Grants, 1782-1792.
- 2. Old Kentucky Grants, 1793-1856.
- 3. Grants South of Walker's Line, 1825-1923, 4,583 separate grants located 'south of Walker's Line' and North of the parallel 36° and 30 minutes, a line which was accurately established in 1819 by Robert Alexander and Luke Munsell, following legislative appointment. Dr. Walker in running his line for the southern boundary of Kentucky in 1779-80, failed to establish the true parallel of 36° and 30 minutes, his line falling variously from 6-10 miles north of the true parallel. Since the old Walker line had been established as the southern boundary and covers a considerable distance, it will be seen that the lands indicated in these grants were really in Tennessee. To settle the matter an agreement was reached in 1820 by the Commissioners selected by the states of Kentucky and Tennessee and furtherance of which Kentucky was given the right to issue grants of all territory lying north of parallel 36° and 30 minutes and east of the Tennessee River. The surveys in this system are not recorded but found in file boxes in the Land Office.

These grants are from pages 892-950, and the Tennessee counties mentioned are Sumner, Smith, Stewart, Fentress, Robertson, Macon, Claiborne, Montgomery and Jackson. An

example of the information given is:

Page 926. Miller, Nursis: 130 acres, Bk 1, page 133, survey date, 9-29-1825. County: Summer; Watercourse: Sulphur Fork or Drake Creek.

For more information or in requesting copies of these grants, one may write to The Secretary of State, Commonwealth of Kentucky, Frankfort, Kentucky".

CORRECTION: The reference in our first issue of 1967, page 35, to The Sylacauga Chapter of the D.A.R. should be to The Fort Williams' Historical Society of Talladega County, Alabama.

Mr. Arnold John Madiol, 436 Orchard Avenue, Grand Haven, Michigan 49417 is expanding his master file of families being researched. He asks anyone anywhere to send him a list of their ancestors and/or also a copy of their genealogy showing names, dates, and places. He offers to place all names in his index and advise of any data. He asks a stamped, self-addressed envelope and time for reply.

The Genealogical Society of the Church of Jesus Christ of Latter-Day Saints, Inc., 107 South Main Street, Salt Lake City, Utah 84111, has sent two research papers, Series A, No. 1 and No. 2, relating to MAJOR GENEALOGICAL RECORD SOURCES IN ENGLAND AND WALES and IN IRELAND, respectively. These data should be of great help to many genealogists.

The Central Louisiana Genealogical Society, P. O. Box 5361, Alexandria, Louisiana 71301, has a new service for genealogists. In November 1966, the ALEXANDRIA DAILY TOWN TALK, a newspaper, began publishing a weekly column for genealogy and local history titled "Louisiana-En Passant". Inquiries should be sent to the Society.

THE VAN DERWERKEN-VAN DERWERKER FAMILY, a record of the descendants of Roelof Gerritse Van Der Werken who came to America in 1663, has been published. It may be ordered from John H. Van Derwerken, Jr., Baronet Litho Co., Johnstown, N.Y. 12095 for \$10.00.

Mrs. Helen Gomer Schluter, 3800 N. Haltom Road, Ft. Worth, Texas 76117, has compiled and published MEMORIES OF SABINE COUNTY, TEXAS, price \$4.00. It contains Gomer family history as well as much genealogical information on other families. She advised us that Mr. J.B. Sanders, 409 Nacogdoches St., Center, Texas 75935, has printed several early census, cemetery, and Masonic Lodge records for several east Texas counties and for Sabine Parish, Louisiana. We also learned that Mr. John Wilkins, 1005 Ross, Lufkin, Texas 75901, has a quarterly publication, RECORDS OF EAST TEXAS, covering 23 county areas, and two issues have been released to date.

We are pleased to see the growing interest in genealogy. We have received a new family journal, MOHR NEWS, edited by Mrs. Gertrude Cornelius Mohr, Route 1, Box 15, Llano, California 93544. At the present time it includes data on the families of Cornelius, Shryock, Easter, Jack, Thomas, Holmes, Spiers, Hubbard, Eckelberry, Mohr, Miskimen, Largent, Addy, Johnson and Roberts.

We also have nationally syndicated columns promoting the interests in genealogy. The column written by AMY VANDERBILT on February 16, 1967, suggested to a group of ladies that they form a genealogical study group for exchange of family data.

THE HOPKINS COUNTY, KENTUCKY, MARRIAGE INDEX, 1869-1900, has been published by Marian G. Hammers, 651 South Scott Street, Madisonville, Kentucky. The book contains 153 pages, 6700 marriages. The grooms are in alphabetical order and there is a bride index. Price is \$10.00.

We were pleased to receive four compilations from the pen of Jean M. Maire. They are GREENE AND JERSEY COUNTIES, ILLINOIS, containing early marriages and Civil War veterans; WAYNE AND CLAY COUNTIES, ILLINOIS, containing 1884 population coverage; BOND AND MONTGOMERY COUNTIES, ILLINOIS, containing 1880-1882 population coverage; and CUMBERLAND, JASPER AND RICHLAND COUNTIES, containing 1884 lists of heads of families and the names of their wives. Each volume of this set (purchasable as singles) is in attractive print and carefully prepared. Thousands of names are indexed in these books.

THE STORY OF HERALDRY. (By Leslie Gilbert Pine. Published by Charles E. Tuttle Co., Inc., Rutland, Vermont, 1966. 164 pp. \$4.75.)

As a former editor of "Burke's Peerage" and "Burke's Landed Gentry", L.G. Pine can speak with authority on the subject of Heraldry. In this book, Mr. Pine has completely revised the text of a book on Heraldry which he originally published in 1952. As stated on the jacket, the book purports to be the "Only book written in English which tells the history of Heraldry in concise and readable form".

And its companion book:

THE STORY OF SURNAMES. (By Leslie Gilbert Pine. Published by Charles E. Tuttle Co., Inc., Rutland, Vermont, 1966. 152 pp. \$4.75.)

This is not a dictionary of surnames and their meanings, but a readable story of surnames and their origins from which an interested person can interpret the meaning of his own surname for himself.

Since both books deal very generally with their subjects, neither book will be of definite help to the genealogist, but each would provide a lovely evening of background reading about subjects of interest to genealogist and non-genealogist alike. Both the development of surnames and the necessity for coats of arms are a part of the background of every American whose ancestry disappears into the mists of the history of the British Isles.

We do appreciate all books given to us and we review each of them in our "Ansearchin' News". We try very hard to see that proper credit is given to the donor but being human we do make errors. We regret very much that such an error was made in our Librarian's report, in our last issue.

We your petition humbly prayeth that your Honourable body (the Legislature) to be holding in Knoxville, commencing the third monday in Septemr 1817; will make such alterations & amendments in the Tobacco Law, as is below insurted, (& as the Tobacco buisiness is likely to become profitable we think it necessary that the Legislator take the buisiness in to there considiration;) (To wit;) that you pass a law for a third inspecter, to attend when either of the other two are absent, or to inspect there Tobacco, or when they split in Judgement, and to have the same fees as the others do for all they inspect; --- also, that there be coopers (or pickers) appointed, to coopper up all Tobacco that shall be inspected, and stow it away, and to pick all Refused Tobacco, if the owner makes choice not to do it him self, and that said coppers find nails and cooper up said Tobacco for fifty cents a hogshead, which money shall be paid by the owner of sd Tobacco to the Inspecters, on Receiving there note for sd Tobacco, and sd Inspecters shall be accountable to the sd Coopers for the same, we think there shall be as many Copers appointed as the Inspecters, shall think surficient for each ware house, and said Inspecters shall Recomend them to the county court, or to any Justice of the peace, whose duty it shall be to qualify them, before they act in there office, and if they are called on to pick any Tobacco, that has bin Refused, that they shall be intitled to one tenth part for there trouble --- also, that there be fifty cents paid for the use of the ware hous and scales for each hogshead, by them that takes it out of the ware house, and the owner of the tobacco have the privilage of letting there tobacco lie in the ware house one year for that sum, if over twelve months fifty cents more; --- also that the Inspection be out the fifteenth of august, and the next new (?) year of inspection commence the fifteenth of November in each year, tho the inspecters be at liberty to attend in ad intervill and Inspect Tobacco but shall be compelled; --- also, that the Inspecters furnish a printed manifest some what like that of a note (or a receipt) for it to certify the Marks nomber gross tare & neet weight of each hoghshead Tobacco, cirtifying it was delivered for exportation in good order and assigned by the Inspecters, and that will show in any part whare the Tobacco May be sent, at what ware house it was Inspected, and by who, as the manifest will accompiny the Tobacco; --- also any tobacco proy ced in hogsheads and not weighing as high as eight hundred & fifty it be called transfer tobacco and the Inspecters Issu there Recipt (or note) for transfer your petitioners are in duty bound will ever pray

To the Honorable the Members of the General Assembly for the State of Tennessee in Your memorialists respectfully represent to your Honbl Body, that from their Short Experience as Inspectors of Tobacca & other produce for Exportation (we having been appointed by the Worshipful Court of Smith County) upon their examination of the several Inspection Laws passed by the State Legislature, they Conceive & pray for Some Small amendments, additionall to said Law. 1st that whereas there are no Publick Warehouses in Said County for the Safe Keeping of Tobacco or other Commodities etc. that, the Inspectors be only Bound to Weigh & Inspect the Same & Deliver it from the Scales to the Owner or Merchant purchasing the Same without any further responsibility on the Inspectors they Giving Certificates as presented by Law & Keeping a record of the Same, also Authorising the County Court to appoint Turners up or Coopers whos duty it Shall also be to pick all Condemned Tobacco (provided the Owners should not do the Same) who may be allowed the Sum of 50 Cents for each Hogshead or Cask for their Services etc. to be paid by the Owner. 2nd That where any private Individual or Inspector furnish Scales & Standard Weights for the purpose above mentioned be allowed the Sum of 50 Cents for each & every Hogshead etc Weighed in Said Scales etc. your petitioners Concieving the fee of \$1 for Hogshead as Heretofore allowed by Law and only a very Small Compensation for their Services for furnishing printed Certificates as Prescribed by Law, also a Bound Book wherein to Keep a proper entery & Record etc. Your memorialists respectfully present the above amendments to your Considerations.

TENNESSEANS IN TEXAS

(Abstracted by Miss Bernice Cole from

"A Memorial And Biographical History of Johnson And Hill Counties, Texas" published by The Lewis Publishing Co., Chicago, 1892)

This series of abstracts began in 1965 when Miss Mildred Dulaney of the Fort Worth Public Library went through the volume of material for McLennan, Falls, Bell and Coryell counties, Texas, and photostated all biographical sketches mentioning Tennesseans. The abstracts from that volume were completed in 1966.

We are again indebted to Miss Dulaney who has now sent photostats of similar sketches from the Johnson and Hill counties, Texas, volume, so that we are able to continue the series.

JESSE M. HILL - Among the many citizens of the South who were loyal to their convictions in the face of the horrors of war, was Jesse M. Hill, whose history is outlined briefly as follows: He was born in McMinn county, Tennessee, January 15, 1839, and is a son of James and Elizabeth (Mayfield) Hill, natives of South Carolina. (p 185)

PHILIP WALKER - One of the oldest settlers of the eastern part of Johnson County, Texas, was born in Chester district, South Carolina in 1815, to James and Martha (Telford) Walker, the former of whom was of Irish descent, and was also born in Chester district. He was a tiller of the soil. About 1821 James Walker removed with his family to Madison County, Alabama, two years later to Jackson County, two or three years were spent in Pickens County, six years in Chickasaw County, Mississippi, one year later in Shelby County the parents were called from life, both dying in 1845. In 1834, Philip Walker left home, came to Texas in the spring of In 1836 while at St. Augustine he enlisted for the Mexican service under Captain William Ratcliffe. After three months active service he received his discharge, in July, and returned to St. Augustine. In 1839, he removed to Shelby County and purchased a headright of 1,400 acres. In 1845, Philip Walker was married to Elizabeth, daughter of Job and Elizabeth (Landrum) Cooper of Tennessee. Children: Martha Ann, wife of John C. Lockett, both dead, three children surviving them; Solon S., a farmer and stockman of Stephens County, married to Clemence Hill, seven children; Sarah Jane wife of William A. Clack, preacher, farmer and blacksmith of Stephens County, and is the mother of three children; James H. a farmer and school teacher of Fisher County, married J. Gathen and has four children; and J. Effie F. married Dr. James Dodson, practicing physician of Newberry, has one child. In 1855, Mr. Walker came to Johnson County. During the Civil War he furnished many horses to the Confederate Army, also beef, blankets, shoes and guns. Mrs. Walker died in 1867 at the age of forty years, and in November 1874 he was married to Eleanor Laney, a native of North Carolina and widow of Squire Stephens. No children by second wife. (p 197-8)

P. J. NORWOOD, of Cleburne, Johnson County, is son of St. Clair and Catherine J. Norwood. The father was born and reared in Blount County, Tennessee. The mother is a daughter of Peter Hoodenpyle, one of the first settlers of Sequachee Valley, East Tennessee. Peter J. Norwood, one of six children, was born in Pikeville, Bledsoe County, Tennessee, Oct. 3, 1842. He entered the Confederate Army in August 1861, enlisting in Colonel Henry Ashby's Tennessee Regiment of Cavalry, began his service in East Tennessee and Kentucky, near Cumberland Gap. He was in the fight at Fishing Creek, later at Chickamauga, Missionary Ridge and Lookout Mountain. Went down to Jonesboro, Georgia; was with Hood on his return into Tennessee, and after the dispersion of his forces at Nashville was part of a detachment that made its way to the Eastern Army, then in North Carolina. He served until the general surrender, was a private throughout, captured but once, held only

a short time. After the close of the war returned home and shortly went to Selma, Alabama, for two years Agent for the old Selma & Meridian Railroad Company. Went to Bayou Bartholomew, Louisiana, engaged in farming for one year but returned to the mountains of East Tennessee. February 11, 1869 Mr. Norwood married Miss Ursaline Schoolfield, a daughter of P. H. Schoolfield, of that place. In 1871 Mr. Norwood came to Texas settling near Garden Valley, Smith County, then moved to Fort Worth. Four years later moved to Kaufman County, purchasing a ranch of 4,000 acres on King's Creek, which he stocked and conducted until 1881, moving near Petrican Springs on Pecos River, two years later moving to Cleburne, Johnson County. (p 338)

- A. H. YEAGER, farmer of Johnson County, native of Washington County, Tennessee, and the third of six children born to C. F. and Selina (Hoss) Yeager, also natives of Tennessee. Entered the Confederate service in August 1861, in Company G, Twentyninth Volunteer Infantry, served with this command through the war. In battles of Corinth, Tupelo, Chickamauga, Missionary Ridge, Kenesaw Mountain, where taken prisoner in June 1863, while on picket duty. Taken to Camp Douglas, Illinois and exchanged in March 1865. Remained in Tennessee from 1865 until 1872, engaged in teaching and was also admitted to the Tennessee bar. Practiced law in that State two years, and in 1872 settled in Alvarado. Three years came to Cleburne and bought a one-half interest in the Cleburne Chronicle, W. H. Graves being his associate. Connected with other county papers until January 1890, when he retired to farm life. He was married in 1882, to Miss Mary V. Hightower, a daughter of V. N. and Matilda (Perkerson) Hightower, natives of Georgia. (p 339)
- A. F. BRANCH, of Hill County, prosperous tiller of the soil. He became a resident of the Lone Star State in 1873. He resided in Denton, Texas for about two years, then went to Lanier County, soon after to Pinoak County, in the stock business until his removal to Louisiana, at the end of one year. He was born in Franklin County, Tennessee, August 25, 1852, brought up on a farm, given a common schooling. His parents, W. A. and Louisa (Cask) Branch, were from the Old North State, father a wealthy farmer, slave owner and operated a large distillery, dying May 19, 1878. Twelve children: Elizabeth married Ben Hutton, came to Texas in 1887, settled in Ellis County; Joel P. came to Texas in 1873, died in 1874; William H. came same time and now a farmer in Ellis County; Martin L. died in November 1887, married Emma Freeman, A. F. Branch's step-daughter, January 4, 1881, having been a resident of the State from 1879; Susan married J. A. Weaver, came to Ellis County in 1882; Nancy L. married H. Fields and still resides in Tennessee; John T. is also in Tennessee; W. A. who came to this State in 1883 is a resident of Kaufman County, unmarried; and the rest of the children died in early childhood. A. F. Branch, the subject, married the widow Freeman, daughter of Joseph Roberts of Virginia. She was born in Rusk County, Texas, July 29, 1849, and by her first husband had five children, four of whom are living: Emma, Milton A., William A., and James F. Mr. Branch and his wife have five children: Amanda E., born August 29, 1875; Nancy T., born February 13, 1877; Mary I., born January 30, 1879; Jesse L., born June 19, 1881; and Alexander V. born October 28, 1882. The father of Mrs. Branch, Joseph Roberts, settled in Rusk County at an early day. He married Rachel Stenson, and died about 1858. His children were named as follows: Virgil A., in Erath County, Texas, farmer; Amanda, the wife of the subject of this sketch; Samantha E., wife of E. Brown, married second time to Moses Ledwell, farmer in Erath; Henry O., resident of Hopkins County, Texas; and Andrew B., farmer of Denton County, Texas. (p 339-40-41)
- S. E. MOSS, Banker, Morgan, Texas, president of the National Bank of Cleburne, Johnson County, Texas, but a resident of Bosque County, son of Azariah Moss, one of first settlers of that county as early as 1834. The elder Moss was born in Wilson County, Tennessee, May 30, 1816, and his parents, John and Susan Moss were both Virginians, but early settlers of middle Tennessee. Azariah Moss remained in his native state until nineteen years of age, then came to Texas, making his home in Bowie County until 1837. Returned to Tennessee, and on the 20th of December of

that year was married to Miss Adeline S. Alford, a native of Wilson County, that State. He again returned to Texas and settled in Red River County, where his wife died November 4, 1848. July 3, 1849, he wedded Miss Christiana Watson, then of Red River County, but a native of Mississippi. Her parents, James and Rhoda (Banfield) Watson, were natives of North Carolina where they married, subsequently moved to Texas, by way of Mississippi, and settled in Red River County in 1835. Mr. and Mrs. Moss resided in Red River County until 1851, when they moved to Dallas County, settling there on the 20th of January. Mr. Moss died February 17, 1888. Eight children: James F., now at Fort Worth; S. E. (subject); Mary, wife of James Allen of Dallas County; Edmund L.; Ida, married Benjamin Franklin, and died December 4, 1878; M. P., still on the old homestead; Robert L. of Dallas County; and Emma, wife of Michael Thomas, of the city of Dallas. The father was a member of the Methodist Church, also of the Masonic fraternity. S. E. Moss was born on the old homestead, between Cedar Hill and Lancaster in Dallas County, August 18, 1853, assisted his father on the farm until 1877, when he began selling lightning rods from the wagon. He owns a ranch of 4,000 acres in Bosque County, a large amount of stock in the National Bank of Cleburne, of which he is president, also stock in the First National Bank of Meridian, of which he is vice-president. Mr. Moss was married July 1877, to Mrs. R. Irving of Bosque County, but a native of Washington County, Texas. (p 342-3-4)

R. L. CARTWRIGHT, farmer of Hill County, was born in San Augustine, Texas, March 15, 1860, a son of Columbus Cartwright. The latter was a son of Matthew Cartwright, a native of Tennessee, who came to Texas in 1823, and to San Augustine in 1825. The family originally came from England. Columbus, the father of our subject, married Miss Sally Lane, of Tennessee, a daughter of Robert Lane, native of the same State. The parents had six children: R. L., our subject; J. M., farmer and stock-raiser of San Augustine; Clinton, farmer of San Augustine; Americus H., Mary C., and Ella, at home. The subject of this sketch received his education in the Vanderbilt University at Nashville, Tennessee. He came to Hill County in June 1883, father and two sons, R. L. and J. M., are engaged in cattle business and raising of horses. Mr. Cartwright married Miss Terie Bickham, who was born July 10, 1862, daughter of John S. Bickham and an own cousin of Dr. C. J. Bickham, a noted physician of New Orleans, Louisiana. The Bickham family are originally from Massachusetts. Mr. and Mrs. Cartwright have had three children: Lena L., born February 6, 1884; Columbus J., November 12, 1887; Elisha B., January 9, 1891. (p 346)

M. D. COLVILLE, farmer of Hill County, was born in Tennessee, September 9, 1830, a son of Joseph and Anna (Gambell) Colville. The parents moved to Arkansas in 1839, and after the discovery of gold in California the father and eldest son started in pursuit of the riches of that State, never again to return. Located a paying mine, worked digging the precious metal until they were attacked by the wild savages, and both were killed and scalped. The mother died in 1874, age seventytwo years. Mr. and Mrs. Colville had twelve children: Sarah, wife of S. A. Prior; Elizabeth, wife of W. R. Serry; Margaret J., now Mrs. John Ford; Olivia A., wife of A. J. Goard, died in 1869; Adaline, wife of J. Robbins; Mary L., now Mrs. J. P. McDonald; Martha L. was married to M. Wilson, and after his death to James Knox; Andrew G., killed in California; Samuel, died in 1869; and M. D. Laura C. married G. T. Wilmoth. Our subject moved to Texas in 1873 and settled where he now lives, about seven miles southwest of Hillsboro. Mr. Colville was married October 15, 1854 to Miss Matilda Vaughan, who was born November 8, 1836. They had fourteen children, eleven of whom are now living; Joseph A.; James A.; Sarah C. W. F. Anderson) Samuel F.; Martha, wife of A. B. Harris; Mollie, wife of A. R. Smoot; Elizabeth, wife of George Perry; Alexander; Caroline; Lillie D. and P. D. (p 348)

JESSE A. McGOWAN was born in White County, Tennessee, June 19, 1841, followed tannery business in youth, now a tiller of the soil in Hill County. His parents,

Samuel and Sarah (Markham) McGowan, were born in Tennessee, and died in 1851 and 1869 respectively, the latter being 45 years of age at the time of her death. Jesse A. McGowan enlisted in the Confederate service, for one year was in Captain Hubbard's independent company, after which he joined a Mississippi regiment commanded by Colonel Perrin, with which he remained until the close of the war. At the close of the war he returned home and was married September 29, 1865 to Miss Deoliece Rosamond who was born in 1849, her father being Samuel Rosamond. Mr. McGowan became a resident of the Lone Star State in 1865 in Henderson County. He next went to Johnson County, from there to McLennan County, remained two years, then moved to Freestone County. His wife died in 1869, at age twenty, leaving him with one daughter, Lillie D., who is at home with her father. He remained in Freestone County until 1876. Miss Lou Williams became Mr. McGowan's second wife in 1876. His second wife died in 1886, leaving four children: Katie L., Walter R., Jesse A. and Henry B. The mother of these children was the daughter of Joseph and Catherine (Roarks) Williams, the former died many years ago, the latter in 1887. (p 357-8)

HENRY C. FORD, Whitney, Hill County, Texas. Native of Louisiana, born in Sabine Parish, November 1, 1844. When six years old came with his father to Texas, settled in Bosque County, in Smith's Bend. Received his education in the County school. Mr. Ford was married in 1865 to Miss Angelina Cox, a native of Kentucky born in 1845, the daughter of William and Mary Cox. Five children: Mollie E., wife of O. H. Young (see Sketch); William T.; John H.; Ola; and Edward (deceased). The mother of these children died in April 1875. Married second wife, Miss Melvia Duncan a native of Tennessee, born October 29, 1856, the daughter of William W. and Dora Duncan. To the second marriage were born five children: Guy W.; Bertha C.; Howland C.; Berrell D. and Charles L. Mr. Ford's father, Thomas Ford was a native Georgian, born in 1807, in 1830 was married to Miss Salantha Liles. He died January 1878 and his wife in 1886. They were the parents of six children: S. W.; Caroline, wife of John H. Mosley; S. A., wife of Dr. Attaway; Thomas J.; Henry C. (subject); and Elizabeth, wife of N. Bryan. Our subject is a Mason, Whitney Lodge No. 355, Knights of Honor Lodge No. 3, 214, also the K of P Lodge of Whitney. (p 359-60)

C. J. SORRELLS, of Hillsboro, was born in Walton County, Georgia in 1856 to John B. and Jane (Tribble) Sorrells, who were born in Georgia in 1832 and 1834 respectively. The father was an extensive planter before the war. He was a Lieutenant in the Confederate service in the Army of Tennessee and with General Forrest's Cavalry participated in the Kentucky raid and was at the battle of Stone River. He left the army in 1864 and was elected Sheriff of his county. He was elected a member of the Constitutional Convention, which framed the present constitution of Georgia, and in 1869, by choice of the people, became their representative to the Legisla-The subject of this sketch is the third of eight children, received his education in Johnson Institute, but left at the age of eighteen. In 1881 he became bookkeeper for Emman & Co., cotton factors at Brenham, Texas, having come to Texas when about 22 years of age. He next superintended the office work for B. H. Sanders & Co., at Cleburne, where he began to class cotton. In 1883 he opened his own office in the same town and for two years was quite a heavy purchaser at this point. Since then he has been a resident of Hillsboro, and in 1885 handled about 5,000 bales. His wife was Miss Josie Kimbrough, born in Athens, Tennessee, and whom he married in 1885. They have one daughter, Annie. Mrs. Sorrells' father was I.B. Kimbrough, a Baptist minister. Mr. Sorrells' paternal grandfather, Charles Sorrells, was a Georgian by birth and was Colonel in the War of 1812. He was born in 1784, died in 1854. His ancestors became residents of Virginia during early Colonial days. (p 366-7)

STORE ACCOUNT BOOK OF SEVIER COUNTY

These data were copied from the original in the Special Collections Room, University of Tennessee Library, Knoxville, Tennessee, by Mrs. James O. Maddux, P.O. Box 71, Spring City, Tennessee 37381. Mrs. Maddux notes that she copied only the date of the first entry and the names included with the entry. The page number in the left column is that of the original entry. Only unusual purchases are shown. Most of the accounts were listed as Sundrys, whisky, shoes, cloth, etc. It appears the book was used between 1796 and 1801. In 1874, a later owner used the bottom of the pages for accounts, but these were not copied. He also gave a list of his property in Jefferson County, made some drawings of the devil, and recorded a recipe for making manure and a cure for distemper.

To the honorable general assembly of Tennessee now in session We your petitioners humbly and Respectfully sheweth to your honorable body That we labour under many inconviniences and disadvantages in consigence of the boundary of this county by that of Roan we who reside near big Tennessee River have to pass through a corner of Roan county to get to our mustering ground (or go around seven or eight miles where there is no road) and those who are eligiable electors for congress and State Legislature so give our sufferages and also our civil officers when an official business in the north eastern part of this county have the above stated difficulty to encounter - We therefore humbly pray your honors to take this our petition into consideration - and add all that part of Roan to Monroe County, East of the black oak ridge and South of Tennessee River, beginning whre Monroe County line cuts Tennessee River, thence down said River passing the mouth of sweetwater creek to the place where the blackoak ridge intersects the same thence along the top of said ridg to Monroe County line by granting our request you will add much to the covience and comfort of the citisens of this county - Your very humble petitioners this 4th October 1825

POST OAK SPRINGS BURIAL GROUND, ROANE COUNTY, TENNESSEE

(Contributed by Mrs. Robert E. Thornton, 308 S. Douglas Ave., Rockwood, Tenn. 37854)

For many years one of Roane County's oldest cemeteries has been inaccessible. In the fall of 1965, following an unfortunate "cleanup" of the oldest public burial ground in Rockwood in which upwards of 148 tombstones were destroyed, interested descendants of people buried in the Post Oak Springs Burial Ground undertook to clean up and maintain that historic cemetery.

Located about two miles from Rockwood at the rear of a residence on Post Oak Valley Road, this cemetery shows evidence of several burials in 1811. It should not be confused with the Post Oak Springs Christian Church Cemetery located nearby which appears to have been put to use at a later date. The Post Oak Springs Burial Ground, about 300 feet square, has been commonly called "Smith Cemetery" or "Owings-Acuff Cemetery" in recent years. It is located at the former residence of Delia Smith, but it appears members of the Walker family were the first people buried there. The will of James Harvey Walker (Roane Co., Tenn., Will Book B, pp. 219-221), dated 1 March 1836, reads:

"First I direct that my body be decently enterred at the Post Oak Springs Burial Ground in said County ... should have my grave and also the graves of all the family of Capt. Sam'l Walker deceased at the burial ground inclosed with brick or fixed in such manner as they may think best".

No visible evidence of the described enclosure exists today. The grave of Letha M. Acuff is enclosed in an iron fence, and one unidentified grave shows evidence of having been enclosed by a limestone wall and perhaps once had a slab of sandstone across the top. Worth noting is the fact that the markers for the Walker family are still legible after many years even though the inscriptions were handcarved on fieldstones which in some instances had been shaped by hand. It appears that some of the fieldstone markers have been unknowingly removed from graves in the cleanup, but many such markers are still in place. Possibly one hundred or more burials have been made in this cemetery, but only 47 markers have inscriptions. Two removals for reinterrment elsewhere have occurred.

Emma Middleton Wells' THE HISTORY OF ROANE COUNTY, TENNESSEE, (Chattanooga, 1927) p. 31, lists seven Revolutionary Soldiers and one other soldier as having been buried at the "Post Oak Grave Yard".

BEAN CEMETERY, RHEA COUNTY, TENNESSEE

(Contributed by Mrs. Ernest Hutcherson, P.O. Box 154, Rockwood, Tennessee 37854)

This old cemetery is located at the south end of the Southern Railroad bridge where it crosses Whites Creek. The creek is the line between Roane and Rhea counties. The first grave is covered with a solid slab of stone placed on top of a wall built up about eighteen inches. There is no evidence of any of the other long graves having been so covered. It bears no inscription. To the left of the covered grave is the grave of Nancy Parks.

Across the upper side of the cemetery is a row of graves removed by the TVA from the Phillips Cemetery. They are marked with undertaker-type markers, bearing name, place from which removed, and a number. Numbers one and forty were found, those not misplaced were labeled as Unid Phillips and Fitzgerald. Removal was made in 1941. The TVA main offices in Chattanooga, Tennessee, have records of the moved graves.

There are many graves marked with field stones. One row of adult graves is marked at both head and foot with large field stones, crudely rocked off to resemble each other, and five more similarly marked at their feet. Timber has been cut from the cemetery as late as 1965, leaving tree tops and brush all over the area and many

broken stones.

Civil War Captain William E. McElwee (1835-1927) wrote in an article published in "The Rockwood Times", March 24, 1910: "Nicholas Nail from Pennsylvania and a cripple from frosted feet during the hard winter at Valley Forge. He settled first on Poplar Creek (Roane County) but after the purchase of the territory south of Emory and north of the Tennessee River (1804), he moved to White's Creek. The tall tree beneath which he was buried has been cut away and the C.S.R.R. (now Southern Railroad) curves closely around the little grave yard at the south end of the bridge over the creek".

Nicholas Nail's will was first probated in 1813 but not recorded until 1828. His widow, Mary Ann, was alive in 1836. The grave covered with the stone slab may be that of Nicholas Nail.

The petition of John Rains of Cocke county and state of Tennessee Humbly shewith that he hath a Desier to be devorsed from his wife Jane Rains who residing in Warren county West Tennessee and that they have been separated nine years or there abouts the reason of my separating from her was that she was Imposiable for me or any other man on earth to Reside with her in pease the I frequently tryed to make her as happy as I could but not withstanding all my efforts to live with her was all in vain. So I had to leave her contraty to my will altho I had lived with her something like ten or eleven years and had six children by her which I was sorry to leave Behind me. I have resided in the county of Cocke for the last seven years and am well known to the citizens of the county of Cocke where I reside, and also to the subscribers who have signed my petition they are my neighbors all of the same county where I reside and have known me for the last seven years, your petitioners believes that the petition above ought to be granted and as such your petitioners is in duty Bound and will ever pray.

WIGGINS-LEE-NICHOLSON BIBLE AND RECORD

(Contributed by Mrs. William Vincent Beal, 215 Pinehurst, Memphis, Tennessee)

This Bible record of Blake Baker Wiggins and his wife, Sarah Lee, of Martin County, North Carolina, is now owned by North Carolina descendants. Mrs. Beal, who gave the data, is their great-granddaughter.

Blake B. Wiggins & Sally Wiggins his wife was married October 17, 1775

Willis Wiggins son of B B & Sally Wiggins was bornd the 20 day August 1777 Baker Wiggins, son of B B & Sarah Wiggins --- bornd 27 day of Novmbr (?) 1779. Patsey Wiggins daughter of B B & Sally Wiggins bornd 15 day of Janry 1782 (?). Samuel Lee Wiggins was borned the 24 day of Jany 1784.

Salley Wiggins Daughter of B B & Salley his wife was bornd the 19th April 1789 Polley Lee Wiggins was bornd 21st Octobr 1791.

Winnifred Wiggins was bornd the 1st day of February at night 1794

Mason L. Wiggins was bornd Jany 22, 1798.

Lawrance Blake Wiggins was born the 10th day of March 1799 (Mistake corrected 1800)

Thomas Nicholson Son of Joseph W Nicholson and Eliza his wife was born 17th day of March 1786

Thomas Nicholson and Winifred his wife (She was Winifred Wiggins) was married 22nd day December 1812

Sally Eliza Daughter of the above $\underline{\text{Naimed}}$ Thomas & Winifred his wife was born 9th day of June 1814.

Little boy son of the above two, Thos & Winifred, was born 1st day of Decr. 1815 and departed this life on 7th.

Winifred Wiggins, daughter of Thomas Nicholson and Winifred his wife was born 8th day of March A D 1817

The following family record was written by Blake Baker Nicholson, son of Thomas and Winifred Nicholson, in 1898, for his niece, Mary Elizabeth Nicholson Russell (Mrs. Alexander G. Russell), 215 Pinehurst, Memphis, Tennessee.

"I commence at Lemuel Nicholson, Jr. who was father of three sons: Thomas Nicholson, Joe Wright Nicholson, Absolem Nicholson.

Thomas Nicholson was father of Jack Nicholson who was father of James Carter Nicholson, who married Miss Sally Matthews. He moved to Water Valley, Miss. and died near that place with no children. Jack Nicholson was also father of John T. Nicholson who went to Miss. and married and died there. I have heard he left some children. Jack Nicholson also left three daughters: Mrs. Leah Hunter, wife of Ben Hunter of Brinkleyville, N.C., Mrs. Martha Walker, wife of Jordon Walker of Plymouth, N.C. and Mrs. Joshua Swift of Plymouth, N.C. Absolem Nicholson married Miss Mann of Nash County. He had one son, Tim Nicholson, and 7 daughters Viz: Mrs. Dr. Bellamy, Mrs. Phillips, Mrs. Jenkins, (who was grandmother of Mrs. Jimmie B. Greaves, widow of Gen. S.A.D. Greaves of Madison Co., Miss.), Mrs. Shelton, Mrs. Jelks, Mrs. Kinchen Taylor, and Mrs. Whitfield. Tim Nicholson married Miss Benson, had one daughter who married Mason Lee Wiggins, died and left no child.

Joe Wright Nicholson married Miss Elizabeth Mann of Nash Co., sister of Mrs. Absolem Nicholson. He lived on Fishing Creek in Halifax Co., He left three sons Viz: James Nicholson, who married Miss Arrington and died leaving one daughter, Eliza, who married Samuel Lewis Arrington, her cousin, who was state senator from Nash Co. for 10 or 12 years, moved to Montgomery, Ala. 1852. He and his wife both died there since the Civil War. He was father of Judge Thomas Mann Arrington and several other children, but do not know the number or names. (They are as good

people as ever lived.) Samuel L. Arrington was grandson of Thomas Nicholson, brother of Joe Wright and Absolem Nicholson. Joe Wright Nicholson's second son, Guilford, lived on Fishing Creek, Halifax Co. and died there. He married Sally Lee Wiggins. He died there in 1836. His wife died several years before he did. His children were Viz.: Mrs. H. D. Hardeman Goliad, Texas who is about ninety years old at this time (1898), Mrs. Dr. James B. Yellowly who died in Philadelphia 1846, Miss Eveline Nicholson who never married, died in 1840, and Joe Wright who died when a boy. His youngest son, Thomas Wright Nicholson, lived to be 68, died on his plantation in Madison Co., Miss. His body was brought back and buried at his home in Halifax Co., N.C. He married Miss Martha E. Thorne. They have 11 children Viz.: Capt. William Thorne Nicholson who was killed at Petersburg in the Civil War, Guilford Nicholson, named for his grandfather, went to Madison Co., Miss. and married Miss Winters (the parents of Anna and Lizzie Nicholson who live in Cal. (Oakland)), Capt. Edward A. T. Nicholson killed near Petersburg, Va. in the Civil War, Thomas W. Nicholson, Jr. was drowned in Fishing Creek when about 12 years old, Samuel Thorne Nicholson, now living, Joe Wright Nicholson, now living, Mason W. Nicholson, now living, James Mann Nicholson graduated at Chapel Hill, very intelligent, came home and in a few days was drowned in Fishing Creek, Emma P. Nicholson married Capt. L. B. Alexander of Charlotte, N.C. Died leaving 6 children, Sally Lee Nicholson married Mr. Hobson of Ala. After his death, she married Mr. Nelson, Annie Nicholson married Frank Nelson, Thomas Wright Nicholson, youngest son of Joe Wright Nicholson was born 1785 at Culpepper's Bridge in Halifax Co., N.C. Died at the place of his birth in 1836 on the 27th of Nov. Was married to Winifred Wiggins of Martin Co. They had 11 children Viz.: Elizabeth died in infancy, Thomas Wright died in infancy, Pattie died in infancy, Winifred Wiggins, educated at Salem, married Capt. Thomas P. Matthews, died in 1839, no children; Guilford John Lawrence Nicholson, M.D., educated in Philadelphia, died in Jackson, Miss. 1844 of smallpox, no heirs. Buried there, grave marked by large marble slab; Mary Mason Nicholson married Col. John H. Harrison in 1848, had 5 children, all living at this time. He was educated at Salem; Joseph James Nicholson was educated at Chapel Hill and read law and practiced till married to Mary Jane Carraway of Lenoir Co., N.C., moved to Miss. in 1853, died in Bolivar Co., and is buried there; Blake Baker Nicholson was born in Halifax Co., N.C., Apr. 20, 1828, married Apr. 15, 1852 to Lucy E. Thorne, sister of Thomas W. Nicholson's wife. They had 11 children. Two died at Montgomery, Ala. in 1863. 9 are living at this time Viz.: Tempie Winifred Nicholson who married Erasmus A. Daniel and has 6 children living; Samuel Timothy Nicholson, M.D., lives in Washington Co., N.C. married Annie Lucas, July 4, 1876, and has 6 children. One of his daughters is Mrs. L. H. Mann of Asheville; John Thorne Nicholson, M.D., lives in Bath, married Katie McNeal of Maryland, has 5 children: Mary Elizabeth Nicholson married to Samuel J. Clark, has 4 children, lives at Enfield, N.C.; Blake Baker Nicholson, Jr.'s education at Trinity College, N.C. and University of Va., Lawyer, lives in Washington, N.C.; Plummer A. Nicholson, M.D., married Estelle Hunter of Brinkleyville, N.C. No children; Lucille Emma Nicholson married James Harris Clark, 2 children at Enfield; William Edward Nicholson, educated at Trinity, married Erma Owens of Oxford, Miss., have 2 children, and he is a preacher in the Methodist Episcopal Church; Kathleen Lee Nicholson (invalid) not married and lives with parents; Laura Thomas Nicholson born March 18, 1836, married Thomas Nelson Jones. Only one child living at this time. She was educated at Salem.

My brother, Samuel Timothy Nicholson was born Dec. 10, 1830 at Culpepper's Bridge, Halifax Co., N.C. He was educated at Emory and Henry College Va. Read law at Judge Pearson's Law School, moved to Madison Co., Miss. 1853; married Meta Jiggetts 1863. He was a gallant soldier during the Civil War. S.T. Nicholson and wife, Meta Jiggetts are buried in Cemetary at Canton.

Lemuel Nicholson, Jr. was the son of Lemuel Nicholson, Sr. who came to this country about or before 1700, from England. He landed on the Va. shore near Norfolk. Married Miss Patience Wright of Norfolk and came to NC. He was either the son of

Sir Francis or Malichi or Maliland Nicholson, an English baronet. He took an active part with Oliver Cromwell and came over with Cromwell's younger brother or nephew who dropped the "m" from his name to avoid arrest.

FAMILY HISTORY SAYS

Joe Wright Nicholson was a soldier in the great Revolution in 1776. Therein had a company of what was known as Regulators and went under the title of Colonel Nicholson--was in the battle of Guilford Court House and numberless skirmishes. That he had a son born on or about the day of the battle and named him Guilford. Mrs. Laura Winifred Cameron of Livingston, Miss. has his sword now. Col. Thomas Nicholson, son of Jo Wright Nicholson, used the same sword in the War of 1812 in which he arose from 1st Lieut. to Colonel.

OWEN AND CROCKETT CEMETERIES, WILLIAMSON COUNTY, TENNESSEE

(Contributed by Crockett's Forge Seat Chapter, Nashville, Tennessee, United States Daughters of The War of 1812)

The Owen family cemetery is located about six miles south of Brentwood, Tennessee, off of the Wilson Pike on Crockett Road. It is surrounded by a high stone wall and is adjacent to the Crockett cemetery. It is across the road from "Forge Seat", home of Samuel and Andrew Crockett, who manufactured rifles, some of which were used by Jackson's men in the War of 1812. These records were compiled by Miss Mary Sneed Jones, Chairman of Lineage and Historical Records, and Mrs. Richard H. Frank, Organizing President of Crockett's Forge Seat Chapter, U.S.D. 1812.

Pages 149-153 - June Term 1825

George Peery vs Francis Ellis

Robert Stephenson was security for George Peery to prosecute his bill, 1 July 1824. To the Honorable the judge...2nd Judicial Circuit...sitting at Knoxville. ...your Orator, George Peery, a citizen of the county of Knox...that about July 1817 your Orator became the security of a certain Robert Stephenson in a note for \$950. given to a certain Francis Ellis a citizen of the county of Roane... Oct. 1822 the said Ellis obtained against your Orator a judgment...\$1027.73...a few days later your Orator paid said Ellis on account of sd judgment \$153...in the spring of 1823 paid ...\$50. in notes on the State bank of North Carolina and \$50. in Current notes of Tennessee banks...your Orator further charges that the said Ellis some time before he sued...(bought a tract of land from John Underwood of Roane County)...promised to pay said Underwood \$1500. ...your Orator became the security for the payment except \$300...May 1823 your Orator paid to said Underwood \$358.75...8 Sept. 1823 paid \$262.50...and at the same time let the wife of said Ellis have \$20. he being at that time from home...believes the wife of Ellis joined in the receipt for \$358.75. ...last spring or winter Ellis asked your Orator for a sight of his receipts...postively refuses to return said receipts...has issued an execution against your orator for the whole amount...has levied on seven of his slaves... prays that said Ellis may answer make...that he may come to an account with your Orator...has paid to said Ellis or to said Underwood on his behalf as above stated...

/s/ George Peery

George Peery swore to the facts as stated 28 June 1824.

Decree: It appeared from the admission of counsel that this cause is settled.

Page 153 - Dec. Term 1825

Margaret Robertson and Nelson Robertson vs Richard Luallen.

W. E. Anderson was the security for the Robertsons to prosecute their bill, 26 Nov. 1823. To the Honorable the Judge of the Chancery held at Knoxville...State of Tennessee...your Orators, Margaret Robertson and Nelson Robertson, Legatees of William Robertson, deceased, that the said William Robertson...before his death and about the year 1809 or 1810 was possessed...of a negro woman named Hannah... twenty seven years of age and one negro girl child of said Hannah...and one other child of said Hannah...said William being some what straightened in his circumstances...borrowed of a certain Richard Luallen of the County of Anderson (Tenn. ...\$400...required...to place in possession of the said Luallen the above mentioned negroes...security...having mutual confidence in each other, no written evidence of their contract...was executed. But your Orators charge...it was well understood... said slaves were only a pledge...William was to have the right...to redeem said slaves...upon paying said Luallen the loane aforesaid...charge that the said William about the year 1816...tendered the pay of said loane to said Luallen... said Hannah at that time had borne other children...said Luallen utterly refused the said William the privilege of redeeming said slaves...said William shortly thereafter departed this life having before his death made and published his last will and testament by which he appointed your Orators his Executors ... devised many Legacies specifically in which said slaves are not mentioned, devised the whole

residue of his estate...to your Orators...said will...been duly proved (does not say in what county)...said Luallen pretends that at the time he obtained said slaves he made an absolute purchase thereof...prays...that said Luallen answer...

Answer of Richard Luallen filed May 17th 1824

...that about 1 Jan. 1809 or 1810...this defendent was at the house of Col. William Robertson mentioned in Complts bill who then resided in Powell's Valley near to Cumberland Gap, when said William Robertson mentioned to this deft. that he had a negro woman and her two children for sale at the price of \$600. and shewed the negro woman to this deft. ...said William Robertson at that time followed the business of buying and selling negroes...at that time this deft. had a large stock of cattle running in the range near the Southern boundary of the State in West Tennessee. In the month of July next...said William Robertson came to the house of a certain John Cox who resided on Cole Water Creek, where this deft then was & proposed to purchase of this deft. about 20 steers...asked \$20. each...Robertson offered \$18. ...deft. proposed to let said Robertson have twenty one of said steers at \$18. each if said Robertson would sell him the negro woman Hannah...and her two children for \$600. ... Robertson replied that he still had Hannah & her youngest child but her oldest child was then in the possession of a Mr. Fulkerson of Lee County, Virginia...that said Fulkerson had a debt on the brother of said Robertson & was about to sue him...had pledged Hannah's eldest child...Fulkerson had agreed to take another negro...& give up Hannah's child as soon as Nathaniel Horbert the agent of said Robertson in selling cattle & buying negroes returned from Virginia he would make the exchange...this contract was made at the house of John Cox in West Tennessee....this deft. went to Robertson with William Graham Esqr. for the purpose of receiving the third negro...Fulkerson had sold the negro to a man by the name of Tittle who had started to remove to West Tennessee but had died on the way in Bledsoe County, had died without a will & his property would be sold & that he Robertson would get one of his brothers to attend the sale & purchase Hannah's child...agreed...matters rested for six or eight months when deft again went to said Robertson for said negro... (Robertson had not been able to buy the negro child)...Robertson said that this deft. could not hold the two negroes then in his possession because he had no bill of sale...first evidence that this deft. had that Robertson intended to act dishonestly...this deft. being illerate did not know what the law was...determined to hold on upon the negroes until they should be taken from him by law...Robertson about that time purchased lands in Madison County, now in Alabama & was making arrangments to remove to that country...once at the house of one John Spessard in Anderson County he offered this deft. \$50. for his bargain...the last time this deft. ever saw Wm Robertson was at the house of William McCamey in Anderson County... Hannah has had four children since he purchased her... two of them died and two are living...this deft. insists that Complts. produce the will of Wm Robertson & prove their right to maintain this suit....

NORTH CAROLINIANS IN TENNESSEE

Part III.

(Contributed by Hugh B. Johnston, Jr., Route 4, Box 133, Wilson, North Carolina)

In August Court, 1825, Nash County, the petition for division of the land of intestate Henry Vick among his heirs included Nancy Vick, wife of Amos Hatcher, "living in Tennessee".

Alfred Spivey of Nash County, North Carolina, died intestate in Tennessee in 1854.

Prior to August 1839 the late Benjamin Cooper of Nash County had "moved to a western county many years previously" and had a son Edmond Cooper and a daughter (or grand-daughter) Delilah Cooper married to David Everett.

On October 2, 1811, Joseph John Sumner, attorney for Temperance Drake of Davidson County (presumably in Tennessee) sold Jesse Griffin of Nash County, North Carolina, 100 acres on Little Creek adjoining Matthew Drake and John Arrington; witnessed by Francis Drake and Elizabeth Drake. (Nash County, Deed Book 7, p. 394)

John Holt (1761-1841) and wife Isabella Perkins (1770-1852) of Williamson County are presumably the couple who married in 1788 in Orange County, North Carolina.

Elias Bowden married Celia Lawrence in Isle of Wight County, Virginia, in 1785, lived for a while in Franklin and Granville Counties, North Carolina, and then went to Henry County, Tennessee.

Andrew Bay of Wilson County, Tennessee, in 1820 had been during the Revolutionary War the Sergeant-Major in the 9th North Carolina Regiment commanded by Colonel John Williams.

Howell Tatum of Davidson County, Tennessee, in 1820, had been Captain in the 1st North Carolina Regiment, commanded by Colonel Thomas Clark, during the Revolutionary War.

Hugh McCrory of Hickman County, Tennessee, in 1820, had apparently been a soldier in the Revolutionary War. He was a brother of Captain Thomas McCrory who died in the North Carolina service, and of Ensign James McCrory who went to Tennessee in 1784 but by 1820 was living in Washington County, Alabama.

Burwell Bunn of Nash County, North Carolina, died about 1804 and his administrator in Tennessee, Willie Bunn, inventoried money and accounts due. The bulk of his estate was in Nash County.

On March 17, 1835, in Henry County, Tennessee, Joseph Hines had been appointed guardian of Mary Ann Hines, an orphan of Frederick B. Hines, and petitioned to recover her property being held by the Nash County Court in North Carolina.

William Westray died in 1848 in Nash County, North Carolina. Two of the infant legatees were Elizabeth Westray and William S. Westray who were residing in Tennessee when executor Samuel Batchelor later tried to settle the estate. A record of November, 1852, revealed that their guardian was William D. Pritchard of DeKalb County, Tennessee.

On January 23, 1811, Ephraim Clibourn of Knox County, Tennessee, sold Matthew Jones of Robeson County, North Carolina, for L50 a tract of land west of Ashpole Swamp adjoining Joshua Clibourn "on the East side of the two Sisters" and William Phillips (patented by James Rowland on December 10, 1790); witnessed by William Barnes and

N. Powell. (Robeson County, Deed Book P, p. 338.)

On February 12, 1825, Wilie Bridger, agent of Benjamin Sholar of Madison County, Tennessee, sold Asa Barnes for \$69.00 a tract of 69 acres in Bertie county, North Carolina, adjoining Martin and said Barnes; witnessed by G. Driver and J.W. Peterson. (Bertie County, Deed Book BB, p. 349)

On November 28, 1811, John Bridgers of Sumner County, Tennessee, sold Elijah Boddie for \$450.00 a tract of 900 acres in Nash County, North Carolina, bequeathed to him and his brother Henry Bridgers by the late William Bridgers, on Swift Creek adjoining the heirs of Denton Mann, John H. Drake, Mrs. Parsy Pitts, Malachi Underwood, William Arrington, and Benjamin Drake's Mill Pond; witnessed by Thomas Ball and S. Hunt. (Nash County, Deed Book 5, p. 383.)
